- To ensure, by exercising the appropriate controls on both the raw materials used and the finished product, that the orders served comply with the requirements of the customers and the applicable legal regulations.
- To be an enterprising organization, avoiding bureaucracy and with a permanent eagerness to maintain continuous improvement in order to provide competitive products of high quality.
- To ensure that employees feel committed to the quality of the products and services marketed by the company, as well as to the care and protection of the environment and their health.
- Eliminate hazards and reduce risks to health and safety at work, establishing a commitment to provide safe and healthy working conditions, with the aim of preventing injuries and deterioration of health by providing resources, firstly to eliminate occupational hazards and, failing that, to minimize them to the point where they are considered acceptable and, ultimately, to protect the worker from the risks present.
